

## Vehicle Safety Rulemakings Mandated by the Infrastructure, Investment & Jobs Act (Pub. L. 117-58)

Statutory deadlines to issue final rules are in red.

All dates provided by agency for rulemaking actions are per the Spring 2023 Semi-Annual Regulatory Agenda.

## • Light Vehicle Automatic Emergency Braking (AEB) with Pedestrian AEB

- Mandated in Section 24208.
- NHTSA issued NPRM in June 2023.

# • Minimum Performance Standards for Lane Departure Warning and Lane-Keeping Assist Systems

- o Mandated in Section 24208.
- o NHTSA estimates that an NPRM will be issued in February 2024.

## • Heavy Vehicle AEB (DUE – November 2023)

- o Mandated in Section 23010.
- o NHTSA issued NPRM in July 2023.

# Advanced Impaired Driving Technology (DUE – November 2024)

- o Mandated in Section 24220.
- o NHTSA estimates that an ANPRM will be issued in September 2023.

## • Rear Designated Seating Position Alert (Hot Cars) (DUE – November 2023)

- Mandated in Section 24222.
- o NHTSA estimates that an NPRM will be issued in February 2024.

#### Reduction of Driver Distraction

- o Mandated in Section 24209.
- o Requires research on driver monitoring systems.

#### Seatback Safety Standards

- Mandated in Section 24204.
- o NHTSA estimates that an ANPRM will be issued in August 2023.

## • Amend FMVSS No. 108 For On-Vehicle Headlamp Testing (DUE – November 2023)

- Mandated in Section 24212.
- o NHTSA estimates that an NPRM will be issued in November 2023.
- o Final Rule to permit adaptive headlamps issued February 2022.

#### • Hood and Bumper Standards

- o Mandated in Section 24214.
- o NHTSA has yet to initiate rulemaking.

## Automatic Shutoff and Keyless Ignition Systems (DUE – November 2023)

- o Mandated in Section 24205.
- o NHTSA estimates that a Supplemental NPRM will be issued in February 2024.

## • New Car Assessment Program (NCAP)

- o Mandated in Section 24213.
- o NHTSA issued RFC in March 2022.
- o NHTSA issued RFC on pedestrian crashworthiness tests in May 2023.

## • Underride Protection

- o Mandated in Section 23011.
- o NHTSA estimates that an ANPRM om side guards will be issued in December 2022.
- o Final Rule on rear guards issued in June 2022.
- o NHTSA issued ANPRM on side underride guards in April 2023.

# • Seat Belts in Limousines (DUE – November 2023)

- o Mandated in Section 23023.
- o NHTSA estimates that NPRM will be issued in January 2024.
